#### Message Actions

I am an advocate for Wire Novato who attended this meeting which would not have happened without our efforts. Over the objections of councilmember Pat Eklund, the City of Novato chose to govern in a bubble, losing an opportunity to take advantage of public expertise and strong community support.

Our well-researched advocacy for an expert attorney, public workshop & timeline, and key ordinance points, were denied or ignored. Though some requests were granted (1,640 foot setbacks, fair public notice & comment period, posting of projects), much remained unaddressed.

Contrary to the city attorney's opinion, localities do have full local control. We urge the community to join us in our continued fight for a public workshop, key ordinance points, competent technical and legal experts, and a moratorium on wireless applications until the new ordinance is passed.

It's all about marketing hype, the telecoms are selling 5G phones now but there is no 5G in Marin, and probably never will be in 95 percent of the County in the distant future.

5G networks rely on thousands of very low powered transceivers that all have to be connected to fiber optic landlines, every one of them. The range is only a few hundred feet, so it will be necessary to have transceivers located basically outside of every few houses in order for it to work, and there has to be a fiber optic line to connect to each suitcase sized box that is the 5G equipment, 5G doesn't use the towers that traditional 3 and 4G radio networks use.

At the present time, 5G is only being tested in large metropolitan areas in very small pockets, like shopping malls (especially where there are Verizon and AT&T phone stores), large buildings, stadiums and in high density downtown areas, there is no 5G in residential areas.

When we look at the geographical areas of Marin, 5G won't work in rural or semi-rural areas because it would be far too costly to run a fiber optic line to each property a install a 5G box, might as well just run the fiber optic line straight to the house and forget about the low powered radio for the last few hundred feet, use Wi-Fi instead to cover the property like they already do.

There are no applications for any 5G boxes now in Novato, not even in downtown, and to put a restriction of 1,600 feet between each 5G box and to ban them from residential areas, I don't think anyone in Novato should worry about "5G commin to town".

**I know a few people who have been brainwashed by this 5G marketing scheme, some think that all mobile phones are using 5G now, but only the newer phones sold have the 5G option, but since there is no 5G, the phones are using existing 4GLTE.**

**Excellent analysis Ron! Besides advocating for a protective wireless ordinance in Novato, we support a fiber optic rollout. Fiber is safer for health and environment, is faster, more efficient, and cheaper in the long run. Although wireless may yield short term profit for telecoms, fiber is better for long term profit, avoids lawsuits, property value decrease, fire risk, and insurance risk to the city from wireless. An infrastructure in Marin for fiber is already in place, and we are seeing the telecoms installing fiber optic cable and selling it to subscribers. But they continue attempting to upgrade private properties with 5G ready boxes, and will apply for more public right-of-ways (ie. light poles) as well, so the fight continues.**

**Yes, the telecoms have been rolling out fiber optic landlines here in Marin for at least 10 years, but they have a long way to go before they cover most of the urban corridor in Marin, and in the less densely populated areas of West Marin, it is unlikely that the telecoms will invest in rolling out fiber optic cables, it's a matter of profits. It is a huge investment to run fiber optic cables, there must be a large amount of users to justify the investment, the telecoms research everything before even considering where to invest their shareholders money. If there are too few users for the fiber optic lines, they will not invest, if they did, they would be losing their investors money. That is the reason why we will never see fiber optic cables or 5G transceivers in most of Marin. Even if the fiber optic cables are run, the expense of installing a 5G site would have to be justified by having enough customers within a few hundred feet of the 5G site. Rural areas will never see 5G, and most likely not any fiber optic cables either. So, people in rural areas will have to rely on coaxial lines (if they are lucky), satellite like StarLink or 4G (if they have coverage) for internet service, for phone service there will be traditional landlines .**

**AT&T even has a fiber optic line that goes from the switch in Mill Valley up to the top of Mt. Tam, that line is then "de-multiplexed" at a box at the top of the Railroad Grade on Ridgecrest Blvd. East and then sent over traditional phone landlines to serve the rest of the State Park and the facilities like the "radar dome" and also the repeaters on west peak. Those repeaters are used for local public agency (MERA) communications, private communications companies and also for cell phone repeating using 3G and 4GLTE, no 5G on Mt. Tam.**

**The Novato City Council obviously needs some technical guidance on on 5G communications, but so do most people too.**

**It is important that whoever Novato hires, that they don't have any ties to the telecom industry. The powerful telecoms are investing millions of dollars in misleading advertising campaigns concerning 5G.
